You are an integral part of making this show a success. So please share on the platforms that you enjoy and get the word out that we are going to have a great show.

Vendor fees are non-refundable.

This year, the event is being hosted, on behalf of Mel Gallup, by the Gooding Quilters—so as vendors we don't lose the momentum of an event she has worked so long to maintain. We have it on good report that there will be some renovation being done on the Home Arts building; the proceeds of this event will be donated for that renovation, rather than to other local community projects as has been done in the past.

We have had a lot of feedback, hoping this could be a two-day event. You have the Fairground staff to thank for making that possible! Thus, on the day of the show, please look for Anna Stearns or any available member wearing name tags... Gooding Quilters. They will help you find your location. Trusting Mother Nature is never good, so we have the early permission of the Fairgrounds staff to set up inside the Home Arts building for those who want larger spaces or have unique displays to set up. No heaters are allowed in that building, so you may want to consider alternative clothing should we be gifted with a chilly day.

Since we will have the security of locked buildings, we are allowed access to the buildings for setup between 4:30 and 7:00 pm May 9th. Should you not be able to do that, it is required that you manage to have your booths set up no later than 15 minutes prior to 9 am Friday and Saturday mornings. There will be access to the buildings beginning at 7:30 am on Friday, and 8:30 on Saturday.

The non-negotiables!

- Vendors and booth participants are responsible for ALL set up, breakdown, and cleaning of the booth area.
- If you cannot stay until 4pm, please do not apply. You may not break down early UNLESS you have sold all your products, or barring the possibility of an emergency, have communicated with a member of the Quilter's Group. You must tear down and clean your booth area, immediately beginning 4:00 pm on Saturday.
- It is your responsibility, as a vendor, to adhere to state tax guidelines in the collection and payment of sales tax. The following steps must be followed online or file via paper at the event.

As an event PARTICIPANT, you MUST do the following:

- 1. Go to tax.idaho.gov/GoToTAP and under "Sellers and Promoters" click "Register as a Temporary Seller or Promoter."
- 2. Choose "Seller WITH Event ID" > "Next"
- 3. Choose "I am going to an event" > "Next"
- 4. Enter the Event ID > "Next"
- 5. Enter your Seller Information > "Next"
- Choose Purpose: "I am not making taxable sales," "I have a regular permit" or "I need a temporary permit." > "Next"
- 7. Review your entry > "Submit"
- 8. Check your email account for further instructions or attached Temporary Sellers Permit (if applicable).

YES, all participants need to register but NO, Regular Sales & Use Tax holders do NOT need a Temp Permit.

- Behavior by vendors or customers judged to be disruptive or detrimental to the peaceful operation of the show will not be allowed and could be asked to leave if necessary.
- Small children brought to the show by vendors must be kept under the supervision of a designated adult.
- Any unsafe or unsanitary conditions should be brought to the immediate attention of the show Manager. Event organizers will address the issues as needed and under laws they are to uphold.
